The Ramsar funding was spent mostly for organizing the training (7,000 EUR), travel expenses for meetings (3,651.06 EUR) and Carpathian Wetland Centre establishment and maintenance (725.02 EUR). Some activities could not be implemented because of not successful public procurement (wetland handbook), lack of human capacity (promotion activities, workshops) and quite complicated legal procedures in the coordinating agency (public procurement procedures, new structure and staff approval). For the Carpathian Wetland Handbook development (Act. 1.2) was prepared a new public procurement for I.2014. It is proposed to use the amount left (about 18,000 EUR – 13,775.06 on the account and 4,233 expected as the second installment of 2013 contract from Ramsar) in 2014 for the activities not completed in 2013 and for the additional activities planned for 2014 according to the plan below.

6. Summary and list of shortcomings and priority areas for action addressed in 2013

In 2013 the effort was concentrated in support of the establishment of the Carpathian Wetland Centre in the facilities of the coordinating institution - the State Nature Conservancy of the Slovak Republic in Banska Bystrica (building and rooms repair, re-furnishing, equipment, exterior and interior facilities for information centre, etc.) for which were used funds from different projects (especially Swiss-Slovak Cooperation Programme - more than 60,000 EUR); a new position in the structure of the SNC SR was proposed to improve the capacity of the coordinating institution with interviews with candidates (approval by the Ministry of Environment is required and expected in the beginning of 2014). After official establishment of the Centre renewed letters of support will be arranged from all Carpathian countries. Written arrangements between the CWI Board, SNC SR, Ramsar Secretariat and Interim Secretariat of the Carpathian Convention will be prepared during COP4 preparatory meetings of the Carpathian Convention. Very good feedback was from the first training supported from the Ramsar core budget and other sources (especially Swiss Financial Mechanism) for education specialists and teachers. Lack of capacity for implementation of the Ramsar Convention and CWI tasks is the main shortcoming in the Carpathian region, therefore it is proposed to orient the future activities of the CWI in training and capacity building. For fund raising were made efforts especially in using Norway grants, including cooperation with other regional initiatives, like Nordic-Baltic Wetland Initiative.
